The undersigned will be responsible for supplying any and all safety equipment (including helmets) undersigned deems necessary for the protection of the youth identified herein.

We, the undersigned, assume all risks and responsibility for the safety of ourselves, as well as the safety of the below named youth, animals used by the youth for the purpose of participation, and other property.

The undersigned hereby release, discharge, agree to hold harmless and indemnify Roundup Ridge Riders officers, members, agents, Roundup Independence Days officers, members, agents and any land owners upon whose land this activity will take place referred to collectively hereafter as "Roundup Ridge Rider agents" from all liability to the youth identified herein and to the extent legally possible do so also on behalf of any future personal representatives or estates, assigns, heirs and next of kin, for any and all loss or damage, and any claims and/or demands on account of the youth named herein being injured, suffering loss of life or limb, or for damage or loss of property during his/her presence or participation at this event. The undersigned also agree to assume all responsibility for the conduct and safety of the youth named herein and any of said youth's property, including animals.

The undersigned hereby warrants and represents that the youth named herein is physically able to participate in this activity and hereby assumes the responsibility for the physical fitness, capacity and ability of the youth named herein to perform this activity. The undersigned acknowledge and agree that the use of all services, livestock, facilities and/or Roundup Ridge Riders agents connected with this activity is at the sole risk of the undersigned and the youth is only being allowed to participate because the undersigned and the youth are accepting all risk to the youth named herein, to the property of the youth or parent/guardian, and all potential liability that might otherwise fall upon those facilitating this event.

I, the undersigned, hereby warrant and represent that (1) I am of lawful age and legally competent to sign this release, (2) that I am the legal parent or guardian of the youth named below, and (3) that I understand that the terms of this release are contractual.

I further warrant and represent that I will comply with and obey all policies, instructions, rules, regulations of the event and will accept the decision of the judges and Roundup Ridge Riders agents, including those outlined herein. This is the entire agreement of the parties.
